Requirements

Tent Requirements Per City of Ruston code, vendors must have a tent with the fire rating of "NFPA 701" on the tag. If you do not have this, NPFM can treat your tent with fire retardant spray for a charge of \$10. **WARNING:** The fire marshal will inspect the market. He has previously requested the removal of tents for non-compliance.

Yes I have the NFPA 701 rated tent. I will need my tent treated for \$10.

I was a vendor in 2016 and my tent was already treated.

Taxes City of Ruston sales tax rate is 9.9% (lower than Tacoma's at 10.1%) . It is in your best interest to track sales separately from other Farmers Markets for tax reporting purposes. The City of Ruston is very small and depends on its tax base! Location Code #2713
